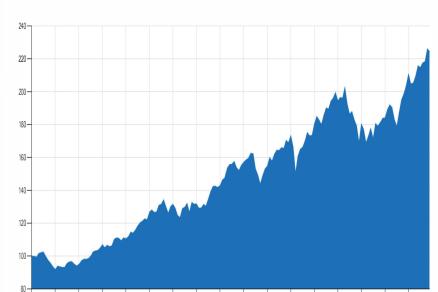

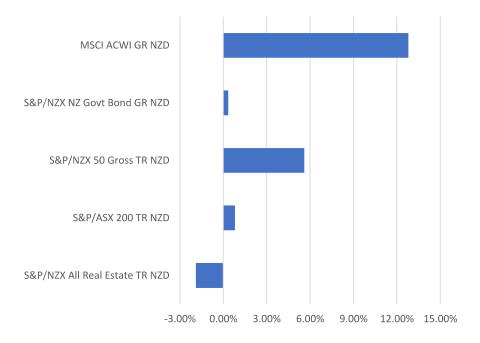
# **Market Summary**

# Shares

The New Zealand sharemarket gained for a second consecutive quarter over the final three months of 2024, despite ongoing weakness in the domestic economy. Further reductions in the Official Cash Rate by the Reserve Bank of New Zealand (RBNZ) and expectations for an improvement in corporate profits next year provided support for share prices. The best performing companies included Hallenstein Glasson +33.7%, Turners Automotive Group 25.2%, and Auckland International Airport +16.5%. Those companies tied to the local economy tended to underperform, including Warehouse Group -11.0%, KMD Brands (owner of Kathmandu) -8.3%, and Fletcher Building -3.4%.

In Australia financial stocks continued to outperform e.g., CBA +13.2% and AMP +19.0%, benefiting from their more defensive qualities relative to the rest of the market. Ongoing uncertainty as to the outlook for the Chinese economy weighed on resource and material companies, BHP and Rio Tinto fell -14% and -9% respectively over the quarter.

# Shares continued

Global equity markets finished the year positively. Returns were also boosted by the weakness in New Zealand, which declined 14.0% versus the US dollar over the last quarter of 2024. The US sharemarket climbed 23% in 2024 as the US economy remained healthy, inflation ticked lower, and big technology companies such as Nvidia powered the US market higher. The US sharemarket performed very strongly in November (+5.7%) following Donald Trump's presidential election win and on the prospects his business friendly polices of lower taxes and less regulation will boost corporate profits in the years ahead.

# **Fixed Interest**

Longer-term US interest rates have moved higher in recent months on the ongoing strength of the US economy, growing concerns over the size of US government debt levels, and the likely inflationary impact of Trump's proposed policies of imposing tariffs and implementing strict immigration measures.

Conversely, global short-term interest rates have moved lower as central banks continued to cut interests. Over the quarter several central banks cut interest rates, including the US Federal Reserve, Bank of England,

and European Central Bank. Further reductions in short-term interest rates are expected over 2025, including in New Zealand.

# Property

The New Zealand property sector underperformed over the December quarter. Despite lower short-term interest rates property stocks gave up some of their strong gains from the previous quarter due to ongoing weakness in the local economy and uncertainty as to the level of rental growth in 2025.

# Outlook

The current environment remains constructive for both fixed income and sharemarkets. This provides a favourable backdrop for a well-diversified balanced portfolio. The pro-growth policy mix of a Trump presidency is supportive of US corporate earnings, particularly for smaller to mid-sized companies. Fixed income offers attractive income yields in the current environment. Short-term interest rates are expected to decline further as inflation pressures ease around the world, this will also be supportive of global sharemarkets.

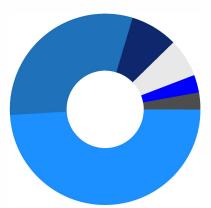

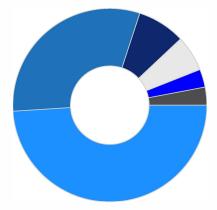
