

Investment strategy

To provide a solution for investors seeking to generate income and have the option of growing their investment over the medium term (more than five years) with medium volatility.

Investment objectives

- > You want to protect your capital, see some growth in the medium term and receive some income from distributions along the way.
- > You are not comfortable with significant fluctuations in your portfolio, but you understand that some risk is needed to achieve moderate growth over the long term.
- > You would accept a potential loss in one year out of every three years.

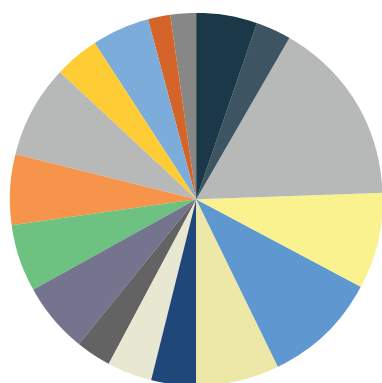
Projected performance

The after-tax, after management fee expected annual return distribution over the long term (below) is based on index data collected since 1993. Actual performance may be different.

A 28% tax rate is assumed, and the effect of the tax rules on the various asset types is calculated. Management fees are assumed at the index fund level. The Select Service and the Adviser Service Fees are not included.

Selected Conservative Balanced Income Portfolio Investment mix as at October 2025 to current

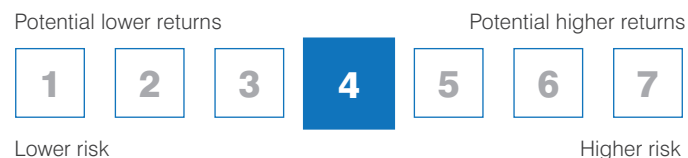
